

NBS CA JCT 'Guidance' update - installation advice

This document provides installation advice and instructions for updating the JCT 'Guidance' displayed in NBS Contract Administrator from 2016 to 2024.

About the contracts in NBS Contract Administrator

NBS Contract Administrator contains four categories of contracts from two providers.

NBS is updating the 'Guidance' for the 2016 versions of the JCT contracts (six in total) to match the 2024 versions. 2011 and 2005 versions and SBCC contracts do not need to be updated.

Installation instructions

Follow these instructions to update the JCT guidance displayed in NBS Contract Administrator from 2016 to 2024.


- This is intended for use with the current version of NBS Contract Administrator v3.0.1.
- NBS Contract Administrator program directory in MS Windows:

C:\Program Files (x86)\NBS\NBS Contract Administrator\Resources

- These steps must be repeated on every device/workstation you have NBS Contract Administrator installed.
 - o This is because, unlike the 'Datastore,' which can be located on the network, the guidance files are stored in the NBS Contract Administrator program directory.
- These steps should be repeated after installing NBS Contract Administrator onto a new device/workstation.

Steps:

- 1. Go to Content and Software Updates | NBS and refer to 'Update 2025-1 April 2025'.
- 2. Download 'NBS Contract Administrator JCT 2024 guidance update April 2025.zip'.
- 3. Close NBS Contract Administrator if you have it open.
- 4. Check the properties of 'NBS Contract Administrator JCT 2024 guidance update April 2025.zip' and 'Unblock' if necessary.

5. Unzip the folder.



6. Copy the 4 files inside the unzipped folder.



- 7. Paste them into the 'Resources' folder in the NBS Contract Administrator program directory: C:\Program Files (x86)\NBS\NBS Contract Administrator\Resources
- 8. You will be shown a message that says, 'The destination has 4 files with the same names.' Click 'Replace the files in the destination'.




A screenshot of the 'Replace the files in the destination' message.

- 9. **Important step!** Check the file properties of each of the four files. If you see this option, you must 'Unblock' the file.
 - a. This is done one file at a time.
 - b. In the NBS program directory (C:\Program Files (x86)\NBS\NBS Contract Administrator\Resources).
 - c. This must be done to:
 - i. DB16.chm
 - ii. IC16.chm
 - iii. MW16.chm
 - iv. SBC16.chm
 - d. Right-click on the filename in the program directory.
 - e. Click 'Properties'.



f. Check 'Unblock' and 'Apply'.

Frequently Asked Questions

1. What does this update include?

This update contains update 'Guidance' for the DB16, IC16, MW16 and SBC16 contracts. This is a guidance only update. There are no changes to the forms.

Please note, when you publish 2016 forms from NBS Contract Administrator they will continue to include '16' in the footer.

NBS Contract Administrator contains digital versions of contract administration forms published by RIBA. We understand that RIBA does not currently plan to publish forms for the JCT 2024 contract editions.

2. After applying the update what will change in NBS Contract Administrator?

The guidance text presented against DB16, IC16, MW16 and SBC16 contracts. This update does not change the forms provided by NBS Contract Administrator. Also, this update will not change any existing jobs or their data.
